Object: **Declaration of conformity to directive 2000-53-CE concerning "End-of life vehicles"**



Dear Customer,

The European Union wants to prevent and to reduce the waste coming from vehicles and to improve the re-use, recycling and other forms of recovery of the end-of life vehicles, their components and materials. In order to ensure these goals, it has been issued the Directive 2000/53/EC of the European Parliament and of the Council of 18 September 2000 on end-of life vehicles.

That directive does not allow the use of lead, mercury, cadmium or hexavalent chromium in materials and components of vehicles put on the market starting 1st of July 2003. However, these substances can be used in certain applications if their use cannot be avoided (see Annex II of Directive 2000/53/EC) according to the following maximum limits:

- 0,1% in weight of lead (Pb), mercury (Hg), hexavalent chromium (Cr⁺⁶);
- 0,01% in weight of cadmium (Cd).

We declare the conformity of the steels manufactured and put on the market by ORI MARTIN to the Directive 2000/53/CE as the substances lead, mercury, cadmium or hexavalent chromium:

- are not used and added during our manufacturing processes;
- are present only in trace amounts that meet the above mentioned limits.
