With reference to the above-mentioned Regulation and following changes and integrations (Commission Regulation UE n. 109/2012 of February 2012; Commission Regulation UE n. 412/2012 of 15 May 2012; ext.), we would like to draw your attention to the following points:

1) Product classification :

According to the REACH classification (substance, compound or article) the products we supply (steel billets, bars and wire rod) are considered as "ARTICLE".

2) O.R.I. MARTIN S.p.A. record of substances

REACH does not request registration of substances recovered from metallic scrap if it comes from EU countries or if it is purchased from not EU countries as waste. All the scrap purchased by ORI Martin is enclosed in such categories, therefore we have not registered it.

3) Suppliers pre-registration details (Supply chain)

Other raw materials used in our production process like alloys or pig iron are purchased from producers or importers with their registered office within the EU.

We request that our suppliers provide the registration details of substances manufactured/imported by the supplier in order to fully monitor the supply chain.

4) Restriction of use for any substances

We inform you that our data shows that products manufactured by ORI MARTIN SPA , with the exception of what is noted in Point # 1, are not in the "**Restriction of Use**" detailed in Art. 67 and on the list provided in Annex XVII of the REACH regulation.

Point # 1: We do not use Nickel alloy (Ni) (EINECS 231-111-4) for the purpose noted in Annex XVII (e.g: production of metallic objects/items designed to be directly in contact with the skin such as earrings, bracelets, etc.)
